THE FIELD DIRECTOR REVIEWS THE MAJOR SECTIONS (WHO RECEIVES THE GRANT AND THE PURPOSE) AND THEN HE SIGNS IT AND SUBMITS IT TO THE DIRECTOR OF FIELD SERVICES.

THE DIRECTOR OF FIELD SERVICES IS IN CHARGE OF THE BUDGET ASSOCIATED WITH THE GRANT; THEREFORE HE DETERMINES IF FUNDS ARE AVAILABLE AND IF SO, APPROVES THE REQUEST, AS DOES THE SCOUT EXECUTIVE.
